Important information

If you are awarded any other scholarship, bursary and / or fee reduction from the University in addition to the Nottingham Law School's Professional Courses Scholarships for Academic Excellence or Outstanding Achievement, the maximum amount awarded will not exceed half the tuition fee, with the exception of candidates who are awarded a full-fee scholarship, or other eligible NLS discount/award or Sport Scholarship.

If you choose to pay your tuition fee in instalments, the scholarship will be applied across all the instalments, rather than in a lump sum at the beginning of the academic year. You will therefore be required to make a tuition fee payment when each instalment is due.
